

AN ORDINANCE AMENDING AN ORDINANCE
APPROPRIATING THE SUM OF THREE HUNDRED
THIRTY-NINE THOUSAND FIVE HUNDRED DOLLARS
(\$339,500) FOR THE DESIGN AND CONSTRUCTION
ENGINEERING PHASES IN CONNECTION WITH THE
ACQUISITION OF AN AIR STRIPPING PLANT FOR
WATER SUPPLY WELL NO. 2 AND A FILTRATION
SYSTEM FOR WATER SUPPLY WELL NO. 3

Be It Enacted By The Town Council In Session:

Section 1. Section 1 of the ordinance entitled "An Ordinance Appropriating The Sum Of Three Hundred Thirty-Nine Thousand Five Hundred Dollars (\$339,500) For The Design And Construction Engineering Phases In Connection With The Acquisition Of An Air Stripping Plant For Water Supply Well No. 2 And A Filtration System For Water Supply Well No. 3", adopted by the Town Council on March 8, 1988, is amended to read as follows:

"Section 1. The sum of \$2,045,000 is appropriated for the planning, acquisition and construction of an air stripping plant for Water Supply Well No. 2 and a filtration system for Water Supply Well No. 3, including design and construction engineering, and for administrative, printing, legal and financing costs related thereto, said appropriation to be inclusive of any and all State and Federal grants-in-aid thereof."

Section 2. The first sentence of Section 2 of said ordinance is amended by substituting the figure \$2,045,000 for the figure \$339,500 therein, thereby making said sentence read as follows:

"Section 2. To meet said appropriation \$2,045,000 bonds of the Town or so much thereof as shall be necessary for such purpose, shall be issued, maturing not later than the twentieth year after their date."

Section 2 is further amended by the addition, after such first sentence, of the following sentence:

"Said bonds may be issued in one or more series as determined by the Mayor, the Comptroller, and the Town Treasurer, or any two of them, and the amount of bonds of each series to be issued shall be fixed by the Mayor, the Comptroller, and the Town Treasurer, or any two of them, in the amount necessary to meet the Town's share of the cost of the project determined after considering the estimated amount of the State and Federal grants-in-aid of the project, or the actual amount thereof if this be ascertainable, and the anticipated times of the receipt of the proceeds thereof, provided that the total amount of bonds to be

issued shall not be less than an amount which will provide funds sufficient with other funds available for such purpose to pay the principal of and the interest on all temporary borrowings in anticipation of the receipt of the proceeds of said bonds outstanding at the time of the issuance thereof, and to pay for the administrative, printing and legal costs of issuing the bonds."

AN ORDINANCE AMENDING AN ORDINANCE
APPROPRIATING THE SUM OF \$1,223,000 FOR THE
WALLINGFORD PUBLIC SCHOOL ASBESTOS ABATEMENT
PROGRAM AND AUTHORIZING THE ISSUE OF
\$1,223,000 BONDS OF THE TOWN TO MEET SAID
APPROPRIATION AND PENDING THE ISSUE THEREOF
THE MAKING OF TEMPORARY BORROWINGS FOR SUCH
PURPOSE

Be It Enacted By The Town Council In Session:

Section 1. Section 1 of the amended ordinance appropriating \$1,223,000 for the planning, acquisition, and construction of an asbestos abatement program for the Wallingford Public Schools, and authorizing the issue of bonds and pending the issue thereof making of temporary borrowings therefor, adopted by the Town Council on November 7, 1988 is hereby further amended by substituting the following, thereby in making said Section read as follows:

"Section 1. The sum of \$1,848,000 is appropriated for the planning, acquisition and construction for an asbestos abatement program for schools in the Town of Wallingford, including design, costs, architectural and engineering fees, administrative, printing and legal costs related thereto, said appropriation to be inclusive of (i) the appropriation of \$90,000 for the preliminary plans for such program adopted at a Town Council Meeting held July 15, 1986, as amended, and (ii) any and all State and federal grants-in-aid thereof. Such appropriation shall be expended in accordance with the following categorizations:

\$1,717,055 Design, construction, administrative,
Industrial Hygiene and contingency

\$ 130,945 Debt Administration

Section 2. The first sentence of Section 2 of said ordinance is hereby amended by substituting the figure of \$1,848,000 for the figure \$1,223,000, thereby making said sentence read as follows:

"Section 2. To meet said appropriation \$1,848,000 bonds of the Town or so much thereof as shall be necessary for such purpose, shall be issued, maturing not later than the twentieth year after their date."
