

SUBJECT: REQUEST FOR POSITION CHANGE

Town Council Members:

In an attempt to bring the Electric Division to full staff, increasing effectiveness and productivity, a change is required whereby the position of Meterman B will become that of Meterman Helper.

The Division currently has a Meterman B position open, resulting from a recent retirement. After the normal advertising process, i.e. internal/external posting, media advertising, etc., was undertaken six persons took the Standard Meterman B test. Of those six, four persons passed. The four candidates were then interviewed; two were found not qualified for the position, two declined the offer.

It was therefore suggested that the position of Meterman B be changed to that of Meterman Helper, in this instance only, thereby filling the vacancy at entry level and allowing for normal progression.

The Public Utilities Commission, at their meeting of December 6th, agreed and approved this proposal.
