ITEM #2 Consider and Approve a Transfer of Funds in the Amount of \$500 to Advertising - Town Clerk's Office

Motion was made by Mr. Doherty to Approve a Transfer of Funds in the Amount of \$200 from Acct. #001-6030-400-4010, Dog Tags & Supplies and from Acct. #001-6030-700-7180, Vital Statistics to Advertising Acct. #001-6030-400-4100 in the Amount of \$500.00, seconded by Mr. Parisi.

Ms. Kate Wall, Town Clerk explained that the emergency transfer is needed due to the fact that on March 6, 1992 she advertised the Democratic and Republican primary. Since then two names have been added to the Democratic ticket and she now has to re-advertise the notice. She was unsure of the cost of the first two publications and anticipating the cost of the second publication appeared before the Council requesting this transfer to cover all costs incurred from the advertising.
