Mary noted that all invoices for our current DEEP trails grant were folded into the first quarterly 2022 report; second quarterly is also submitted; reimbursement will go to our engineering and permitting vendor SLR. The \$280,000 we didn't get in our most recent submittal for DEEP grants money was replaced by CT Dept of Transportation. DOT will add \$280,000 to our existing \$400,000 Connectivity Grant. A pre-fabricated bridge option could work well, similar to what is on the southern portion off Fireworks Island.

The Community Foundation for Greater New Haven grant for signs and bench has been renewed, and there is a small amount remaining from the Rotary Grant.

Cathy suggested that we host the Winter Holiday on the Trail with a single carriage. We might charge a small fee per ride. Also have the scavenger hunt, mailbox, Santa Claus, hot cocoa, donations of food, perhaps a sponsor for the event. This year we can have an online program rather than a printed one.

Choate will work with the QRLTAC on a specific project on September 24th, this is separate to our annual Fall Cleanup which will be in late October.
